NORTH BRUNSWICK – On Monday, September 21st JNESO District Council 1, representing more than 5,000 nurses and other healthcare workers, released the following endorsements for New Jersey General Assembly. The candidates were unanimously approved by the Board of Directors, led by Board President Elfrieda Johnson.

“After a comprehensive review of voting records, public positions, and responses to our questionnaire, we endorsed a group of individuals who we believe will fight for New Jersey’s patients and healthcare workers,” said Johnson. “As healthcare continues to evolve, we need leaders who will fight for us and work alongside us to preserve and improve the quality of care in our state.”

Among the top issues for the union include safe staffing legislation, the reinstatement of regular hospital inspections, and the pending sale of St. Michael’s Medical Center in the City of Newark.

“In the coming weeks, JNESO members will receive regular mailings and outreach regarding our endorsed candidates so that they know who stands with us on the issues that matter most to our membership,” said Johnson. “These are people who have stood with patients and healthcare workers, and for that they deserve our support.”
